FACTS Financial Account for Tuition Payment Plan (Online Payment Services and Secure Financial Aid Assessment):

- This platform allows the responsible party to make payments to ECS for tuition and other incidental billing such as lunch ordering and extended care payments.
- To setup a FACTS account, you will need to create a username and password for the FACTS Family Portal (if you do not already have an account). You can do this by visiting the school website, www.epworthcs.com and click on the ‘PARENTS’ tab, then click the **RENWEB-District Code ‘ECS-DE’** link from the drop-down menu.
- If you are already enrolled in FACTS, you do not need to enroll again. The enrollment carries over from year to year. You will no longer need two different logins for the FACTS Family Portal and the FACTS Financial Account page. You will use your FACTS Family Portal to access your FACTS Financial accounts. There is now a tab on the Family Portal that reads **Financial** and this is where your Financial Account can be found along with links to the Grant & Aid page. Your Grant & Aid will need a separate login once you navigate to that site.
- When making a FACTS Financial Account you must either link your bank account information (ACH) or provide your credit card information. If you choose to use your credit card, FACTS does charge a service fee of 2.95% for each transaction.

FACTS Financial Aid Assessment (Deadline April 15th, 2024)

- Available for grades Kindergarten through 8th and the application opens on February 5th.
- The aid opportunity through Cornerstone Education Scholarship funded in part by Mountaire and administered by ACE, has an updated application process and can be found in the Grant & Aid link on the **Financial** tab in the Family Portal. More information can be found on our website under the ‘REGISTRATION’ tab.
- You will use a different FACTS username and password for Grant & Aid. If you do not have a FACTS Grant & Aid account, you will need to create one.
- Go to the “Grant & Aid” section to complete your information for assessment. You must apply each academic year for Financial Aid.
- All information must be completed before you are considered for Financial Aid.
- Also, your child must be enrolled to be considered for Financial Aid.

Please check this box if your family will be applying for Financial Aid.



Late Fees / Returned Checks / Past Due Tuition

- Any missed payments to the school, to include tuition, fees and extended care, will incur a \$25 late fee for each month it is late.
- Returned Checks: \$40 fee for each returned check.
- **With all credit card payments, a 2.95% service fee will be added to cover bank fees**
- Insufficient Funds with FACTS: If FACTS is unable to obtain your payment due to insufficient funds, a grace period will be offered. **FACTS does charge \$30 charge for insufficient funds (prices subject to change by FACTS Management).**

Refund Policy

- **Registration fee is non-refundable.**
- **You will be responsible for the first 2 months of tuition if withdrawing after August 15th. Records will not be forwarded to another school until your financial obligation to ECS is fulfilled.**
- **When withdrawing, the Financial Office will determine the amount due. That amount will be pro-rated based on your payment arrangements and withdraw date. Early withdraw will result in full payment for the current month.**

TUITION DISCOUNTS:

- **Full Tuition Payment Discount:** This is a 2% discount that is applied if your family chooses to pay tuition in full. This discount is available until June 20th, 2024. After this date, a discount is no longer available and full tuition payment must be made by July 22nd, 2024.
- **Other discounts include the Central Worship Center Member discount and Pastor discount.** There is also a discount for any families who have children attending Little Paws Daycare or Preschool and also enrolled at ECS.
- **Please contact the Financial Office for more information on discounts.**
- **Discounts will only be applied after families have made FACTS Family Portal account and have been linked/mapped to the FACTS Financial account system. You will receive an email when the discount has been applied to your FACTS Financial account. Discounts will be applied before automated tuition payments begin.**
