



ECS-FACTS FINANCIAL TUITION PAYMENT PLAN INFORMATION

FACTS Management is the company ECS uses for families to make FACTS Financial Accounts with and who processes payments such as tuition and incidental billing (lunch orders, extended care, etc.). All families will need to enroll in FACTS and make a FACTS Financial Account. Your Family Portal login will be how you access your FACTS Financial Account. This can be found under the **Financial** tab on the left menu bar on the Family Portal. There is a separate login for FACTS Grant & Aid, which you can find under Financial Links once in the **Financial** tab on Family Portal.

If you do not have a FACTS Family Portal login yet, please be sure you have created one by using the instructions below. All first-time users and new families will need to do this in order to make a FACTS Financial Account.

Instructions for Creating a FACTS Family Portal Login:

- Please go to www.renweb.com. or visit the school website at www.epworthcs.com and click on the 'PARENTS' tab, then click on the 'RENWEB-district code ECS-DE' link from the drop-down menu.
- Select **Parent Login** and select **FACTS Family Portal** from the drop-down menu.
- Enter the **ECS-DE** for the district code
- After the Parent Login screen opens, please select **Create New Family Portal Account**.
- Enter your email address.
- Click **Create Account**
- You will receive an email from SIS Customer Support containing a link that will allow you to create your username and password. For security purposes the link will remain active for six hours.
- After saving your password, go back to the FACTS Family Portal and login.

If you are already enrolled, you do not need to enroll again. FACTS will rollover to the new school year. Existing families will now access their FACTS Financial Account through the Family Portal. This eliminates the need to have separate logins for this process. Information about this can be found above.

New families or new siblings added to existing families will have to wait until the registration process is complete and student is put in FACTS SIS in order to move forward with the Financial portion discussed here.

Tuition Payment Plans:

The full tuition plan can start as early as re-enrollment begins, as long as you have created a FACTS Financial Account and provided your banking information or provided a credit/debit card. NOTE: FACTS does charge a 2.95% service fee for each transaction with credit/debit card use. FACTS charges a \$25 yearly fee for use with full payments and \$55 yearly fee for use with multiple payments (10 or 12-month payment plan option). The 10-month and 12-month payment plan options both begin in August. Payments are taken out either on the 5th or the 20th of each month for payment plans.

The 12-month plan begins August 2024 and ends July 2025. Families can choose the 10-month plan which begins August 2024 and ends May 2025. This option is great for families who need summer care and want to complete school tuition payments early. Payments are automated each month from the account of your choice.

In order to be on schedule for August payments you must be enrolled in the plan no later than August 1st, 2024. Failure to meet this deadline will result in higher monthly payments.
